MEETING WITH THE SHIPPING MINISTRY'S NEW ACTING PERMANENT SECRETARY & CYPRUS STOCK EXCHANGE



The Chamber welcomed at its offices the Stock Exchange President Mr. Cyprus Marinos Christodoulides and Director General Mr. Nicos Trypatsas on 27 September 2021. During their visit, they met with the Chamber's President, Mr. Themis Papadopoulos and Immediate Past President, Mr. Philippos Philis, exchanging views and information on matters of mutual interest. The CSE briefed the Chamber's representatives about their future plans pertaining to the privatisation of their Organisation and examined ways of further cooperation with the Cyprus Shipping Industry.

Later this day, the Chamber's Board of Directors met with the new Acting Permanent Secretary of the Shipping Deputy Ministry, Ms. Liana Charalambous Tanou, which was appointed recently by the Council of Ministers. The Chamber's Board congratulated Mrs. Tanou on her new role and gave her a briefing on a number of important operational issues the Shipping Industry is currently facing.

RESTARTING CSC PHYSICAL MEMBERS' MEETINGS



The Cyprus Shipping Chamber, following all the required safety measures resumed its physical Monthly Members' meetings on 14 September 2021, at the Amathus Beach Hotel, in Limassol. For this Meeting there was a presentation by Mr. Hugh Griffiths, a private consultant working with the US Embassy in Cyprus in the field of sanctions and counter-proliferation finance regarding the topic: "Maritime and related financial sanctions: a perspective from the last decade".

Since 2010, the maritime domain has emerged as a main focus area for multilateral and autonomous sanctions regimes, second only to those found in the financial sector. Mr. Griffiths' presentation explored risks and lessons learned from UN, EU, U.S. and other autonomous sanctions regimes in the maritime domain covering the Democratic People's Republic of Korea (DPRK), the Syrian Arab Republic and the Islamic Republic of Iran. In addition, the presentation focused on the findings and personal perspectives of a UN Security Council sanctions investigator (2014-2019) and Stockholm International Peace Research Institute researcher (2008-2014) that may be of assistance to the private sector when developing risk mitigation strategies.


EDUCATIONAL ACTIVITIES COMMITTEE |21 SEPTEMBER

The Committee noted a brief update on the schools/companies that participated in the "Adopt a Ship" Programme last year. For this year, the Secretariat has developed Programme guidance to be shared with schools and Members and also created online application forms for both schools and vessels. The Committee also discussed the creation of a film on career in shipping which the Secretariat will project during visits at schools and universities for career presentations. A relevant proposal will be submitted to the Board of Directors for approval. The Committee noted that the SDM will organise a "Sea and Maritime Festival", on 23 October 2021, as part of its public relations campaign to enhance maritime culture in Cyprus and it was agreed that members of the Committee will assist the Secretariat during the day in offering career advice to the public.

HEALTH, SAFETY & ENVIRONMENT COMMITTEE 22 SEPTEMBER

The Committee meeting on 22 September 2021 reviewed and approved the consolidated results of the Marine Injury Statistics for the period 1 January – 30 June 2021, discussed a possible agenda of issues to be discussed with RightShip at a meeting to be arranged soon with the Chamber, and noted developments on DryBMS, the new rating system from Scope called Ship Review, piracy and in particular in the GOG region and port state control. Mention was also made to the EU ETS and the FuelEU Maritime proposals and it was agreed to hold a separate specific meeting to discuss these proposals in more detail.

ICS BOD MEETING |LONDON, 14 SEPTEMBER 2021



The International Shipping Chamber, which represents national shipowners' associations on a global basis, held a meeting of its Board of Directors on 14 September 2021, in London, during which the President of the Cyprus Shipping Chamber, and Vice-President of ICS, Mr. Themis Papadopoulos and the Director General, Mr. Thomas A. Kazakos, represented the Cyprus Shipping Industry.

Among the main topics discussed, were ongoing technical and environmental shipping issues, arising from various environmental regulations, by the European Union and the International Maritime Organisation and the way forward in order to adopt them in a non-threatening way for the coherence and stability of the Shipping Industry.

ECSA BOD MEETING |BRUSSELS, 30 SEPTEMBER 2021



The European Community Shipowners' Associations (ECSA), representing the national shipowners' associations of the European Union, held its Board of Directors Meeting on 30 September 2021 in Brussels. The Chamber's Board Member, Mr. Philippos Philis and Director General, Mr. Thomas Kazakos, represented the Cyprus Shipping Industry as part of the Cyprus delegation. Mr. Philis participated in the meeting also under his capacity as Vice-President of the European Shipowners' Association, pending his inauguration, as President of the Association, in January 2022.

During the meeting, the developments of key policy issues concerning European Shipping and the strategic actions of the Association address them, to were discussed. In addition, the Board of Directors discussed the current environmental challenges, such as the inclusion of Shipping in the European Commission's Climate and Energy Package by 2030 ("FIT for 55"), the significant efforts by the European Shipping Community to achieve environmental objectives, the implications of the pandemic, as well as other internal matters of the Association, in relation to its current and future activities.

WORLD MARITIME DAY, 30 SEPTEMBER 2021



The Cyprus Shipping Chamber welcomed the celebrations of the "World Maritime Day", which has been established by the International Maritime Organisation (IMO) and celebrated globally every year at the end of September. As known to the Industry, the purpose of this day is to underline the significant role of Shipping, which has been further highlighted during the ongoing pandemic, since it continued moving 90% of world trade. In addition, it highlights the significant progress made by the global Shipping Industry over the years, on matters regarding the safety and protection of the marine environment.

This year the IMO is focusing "World Maritime Day" around the frontline workers of Shipping

with the theme, "Seafarers: at the core of Shipping's future", seeking to increase the visibility of seafarers by drawing attention to the invaluable role they play now and will continue to play in the future.

On the occasion of "World Maritime Day", the Cyprus Shipping Chamber and a number of its Member-companies, participated at a Beach Cleaning initiative of Akti Olympion B', organsised by the Cyprus Marine Environment Protection (CYMEPA) Association and the of the Representation European Commission in Cyprus, on 30 September 2021.

The Institute of Chartered Shipbrokers - Professional Qualifying Examinations (PQE)

The Professional Qualifying Examinations (PQE) are the entry level requirement for membership with the Institute of Chartered Shipbrokers. The mission of the Institute is promoting professionalism in the shipping industry worldwide. Once you pass the examinations you are eligible to apply for membership.

The examinations take place in Limassol each year in May and November as arranged by the Cyprus Branch of the Institute.
