NEW SHIPPING MINISTER MEETS WITH CSC BOARD OF DIRECTORS



Following a relevant invitation on the occasion of her recent assumption of duties, the new Shipping Deputy Minister, Mrs. Marina Hadjimanolis had an official meeting, on 13 March 2023, with the Cyprus Shipping Chamber's Board of Directors, at the Chamber's office, in Limassol.

Taking the opportunity of the curtesy meeting, the Chamber briefed the Shipping Deputy Minister on the current issues affecting the Cyprus Shipping Industry and its immediate needs. Among others matters, it emphasized the need for the further upgrade of the services offered to the Shipping Industry with the immediate creation of a specialised "One-Stop-Shipping-Centre" at the Shipping Deputy Ministry, the complete digitalisation of the Shipping Ministry and the implementation of the Bill for the formation of a Cyprus Shipping Company with Limited Liability, so that the Cyprus Maritime Administration can become even more competitive. At the same time, an update was given on the ongoing decarbonisation efforts of Shipping and the long-standing issue of the Turkish Embargo on Cyprus ships.

Following a constructive discussion, Mrs. Hadjimanolis stressed the importance that the Maritime Administration places on the longlasting and multifaceted support received by the Shipping Chamber and stated that the Government will offer its complete support on all matters discussed.

Finally, the Shipping Chamber expressed its warmest wishes for a successful term of office to Mrs. Hadjimanolis and its intention to further strengthen the already close cooperation with the Shipping Ministry, aiming for even more positive results.

CSC MEMBERS MEETINGS HELD IN FEBRUARY AND MARCH



The Chamber held its **February Members' Meeting**, on 9 February, in Limassol, during which Mr. Mr. Elias Psyllos, Vice President of T&T Salvage, gave a presentation about the "Golden Ray -The Largest wreck recovery recorded in US history".

Mr. Psyllos presented the innovative technology used by T&T Salvage for the wreck removal of the 2016 built, car carrier GOLDEN RAY, which came to rest on 8 September 2019, at Saint Simons Sound, Brunswick, Georgia, USA with over 4,000 cars onboard. The GOLDEN RAY was a 7,700-unit pure vehicle carrier designed with 13 cargo decks in total, with 4 movable decks and 9 fixed decks. The wreck removal was achieved despite working through the COVID-19 pandemic and other challenges.



On 29 March, the Chamber held a Members Meeting during which the topic of "The inclusion of maritime activities in the EU-ETS/ opening an account in the Union ETS registry", was presented by Dr. Theodoulos Mesimeris, the Head of Climate Action Unit - Senior Environment Officer, Department of Environment of the Ministry of Agriculture, Rural Development and Environment.

Dr. Mesimeris, provided details on how the EU ETS directive has been amended to include maritime activities with particular emphasis on the process to open an account in the Union ETS registry.

FAREWELL LUNCHEON WITH THE OUTGOING SHIPPING MINISTER



Following the appointment of the Government's new cabinet, and the appointment of a new Shipping Deputy Minister, the Chamber's Board of Directors held a luncheon to honour the outgoing Shipping Minister, Mr. Vassilis Demetriades, to express its appreciation for his work during his term of office.

The Chamber's Board of Directors, expressed their sincere appreciation to Mr. Demetriades for his valuable contribution and tireless efforts to further upgrade Cyprus Shipping and offered its best wishes for his future endeavours. As a token of appreciation, a commemorative gift was given to Mr. Demetriades from the Chamber's President, Mr. Themis Papadopoulos on behalf of the Shipping Chamber.

Mr. Demetriades thanked in return the Chamber for the close cooperation and invaluable contribution to the Government's efforts in relation to Cyprus Shipping.

"THE FUTURE OF ALTERNATIVE FUELS IN SHIPPING" EVENT




The Chamber had the pleasure to support and address the "The Future of Alternative Fuels in Shipping" Event, held by the British High Commission in Cyprus, on 2 February.

CSC Director General in his welcoming address, highlighted the Industry's commitment and efforts towards the decarbonisation of the Shipping Sector. In addition, he mentioned need to establish urgently a Global Fund to support the Shipping Industry to develop the needed alternative fuels and infrastructure to meet the IMO targets which are approaching fast.

Two keynote speeches were made by Mr. Gwilym Stone, the Deputy Director Regulations & Standards at Maritime and Coastguard Agency, on the topic "Regulations for Alternative Fuels -'Straitjacket' or 'Springboard?" and by Mr. Sunil Krishnakumar, Senior Technical Manager of the International Chamber of Shipping.

COMMERCIAL OPERATIONS & TRADE FACILITATION C/TEE, 6 MARCH

The Committee reviewed the revised draft of the SHIPMAN Agreement with special focus on the two main items considered by the BIMCO SHIPMAN Sub-Committee, relating to the ETSA clause and the Sanctions clause. With regard to the ETSA clause, discussions concentrated on the satisfaction of the Managers, possibly by introducing some kind of re-assurance or form of security that the owners can or will fulfil their obligations to pay the ETS allowances. It was generally considered necessary that some form of a financial security mechanism was required from the shipowner and a number of suggestions were tabled on the form that this financial security could take. With regard to the Sanctions clause, a custom-made Designated Entities Clause, to be streamlined accordingly together with other clauses in SHIPMAN which involve indemnities, was the most suitable Sanctions clause for SHIPMAN.

EVENTS COMMITTEE, 8 MARCH

The Committee held its first restructured meeting to discuss the organisation of the Chamber's forthcoming events: Annual General Meeting (9th May, Four Seasons Hotel), Annual Dinner Dance (7th July 2023, provisionally date, venue tba),

"MARCY 2023" Conference (8th to 11th October 2023, venue tba) and CSC "35th Year Anniversary" Gala Dinner (26th January 2024, Hilton Hotel, Nicosia).

MARINE INSURANCE COMMITTEE, 16 MARCH

The Committee reviewed the current state-ofplay of the Hull, P&I and Reinsurance Markets Post 01/01 and 20/02 renewals taking into account the challenges of the market. It also considered the impact of the provisions of the latest sanction package issued by the EU against Russia, on Marine Insurance and members shared the view that, the EU sanction packages made the administration of sanction compliance even more problematic and whilst there was a wider acceptance that due diligence and sanction tests should be carried out by all on an individual basis, it was thought prudent to investigate the possibility of introducing a standardized form of a sanction compliance test or questionnaire across the industry. Members also shared information and experiences with regard to the activation of the Blocking and Trapping clause on the anniversary of the war in Ukraine and took note of the forthcoming 1st CSN Cyprus Marine Insurance Conference to be held on 11 May 2023 at the Carob Mill Conference Centre, in Limassol.

MARINE COMMITTEE, 28 MARCH

The Committee received an update on the latest developments related to compliance with the GHG Short-Term Measures, the GHG Global Fuel Standard (GFS) concept, the Lifecycle Analysis of Marine Fuels (LCA) from IMO, the ICS submission for the development of IMO market-based measure (MBM) and the EU Fit for 55 package status. The Committee also reviewed the Norway submission at IMO proposing the comprehensive review of the ISM Code and the China submission on a comprehensive review of the 1972 COLREGS convention.

ICS BOARD OF DIRECTORS MEETING IN LONDON



The International Chamber of Shipping (ICS), held its Board of Directors meeting on 7 February, in London. The Chamber's President and ICS Vice Chair, Mr. Themis Papadopoulos and Director General, Mr. Thomas Kazakos, attended the meeting, representing the Cyprus Shipping Industry.

The meeting focused on the current developments surrounding maritime policy issues, the as well as sustainable implementation of the European Union and International Maritime Organisation's environmental regulations, with the aim of facilitating the sector's green transition.

In addition, ICS Board looked at other challenges faced by the Shipping Industry, including the ongoing war in Ukraine and the G7/EU price cap imposed on Russian oil exports which has a direct impact on shipping and to the safe movement of Seafarers.

ECSA BOARD OF DIRECTORS MEETING IN BRUSSELS



On 16 March, the ECSA Board met in Brussels for the first meeting of 2023. The Chamber's Director General participated in this meeting, as part of the Cyprus delegation, under the chairmanship of the ECSA President, Mr. Philippos Philis.

During the meeting, the ECSA Board welcomed Fund. Beatriz Yordi, Director for Carbon Markets from the Directorate General for Climate (DG CLIMA) for a keynote speech.

Members exchanged views with DG CLIMA on implementation of the EU ETS to shipping and on the work still to be done before the legislation becomes applicable, including on setting the criteria for accessing the ETS revenues that are earmarked for shipping under the EU Innovation Fund.

Members of the Chamber's Board of Directors met with the British High Commissioner, Mr. Irfan Siddiq, on 21 February 2023 at the Chamber's Offices. The High Commissioner was accompanied by Mr. Andrew Wilson, Head of Political Section and Ms. Elena Orphanidou, Director of the Trade Department of the British High Commission. A number of issues affecting Cyprus Shipping were discussed during the meeting with particular mention to the issue relating to the UK Minimum Wage Law.

MARITIME CYPRUS ORGANISING COMMITTEE, 3 MARCH

The Organising Committee for Maritime Cyprus 2023, met on 3 March at the Shipping Deputy Ministry to proceed with the progress of the Conference's organisation. 
THE INSTITUTE OF CHARTERED SHIPBROKERS - PROFESSIONA QUALIFYING EXAMINATIONS (PQE)
