#### "MARITIME CYPRUS 2023" CONFERENCE HELD WITH SUCCESS





The international Conference "Maritime Cyprus 2023" was concluded with great participation and success once again. The Conference took place between 9-11 October 2023, organised the Shipping Deputy Ministry in cooperation with the Cyprus Shipping Chamber and the Cyprus Union of Shipowners, at the Parklane Resort & Spa, in Limassol.

The official Opening Ceremony of the working deliberations of the Conference on Monday, 9 October 2023, made by H.E. the President of the Republic of Cyprus, Mr. Nikos Christodoulides, was preceded by the Opening Reception earlier on Sunday, 8 October 2023, at the Presidential Palace where the "Cyprus Maritime Award 2023" was bestowed.

The Conference was a true celebration of maritime affairs, attracting over 900 prominent Shipping Industry representatives, decision-makers and top management from around the globe, demonstrating the significance of the Conference and Cyprus' Maritime Industry as a whole.

The theme for this year's Conference was, "Shipping in Action: An Agenda for Change," focusing on critical issues related to upcoming and regulatory changes in international maritime arena and the active steps the Maritime Sector is taking in that direction. The official Opening Ceremony of the working deliberations of the Conference on Monday, 9 October 2023, was addressed by H.E. the President of the Republic of Cyprus, Mr. Nikos Christodoulides, who emphasised importance of the Shipping Industry in Cyprus' economy, its competitive advantages, and the government's efforts to enhance further Cyprus's role at an international and regional level in shaping shipping policies.

Prominent stakeholders and professionals from the shipping world, including Mr. Kitack Lim, the Secretary-General of the International Maritime Organisation (IMO), Ms. Adina Vâlean, the European Commissioner for Transport, Mr. Emanuele Grimaldi, the Chairman of the International Chamber of Shipping (ICS), Mr. Philippos Philis, the President of the European Community Shipowners' Associations (ECSA), and Mr. Arsenio Dominguez, Secretary-General elect of the International Maritime Organisation, actively participated in high level discussions.

#### "MARITIME CYPRUS 2023" CONFERENCE HELD WITH SUCCESS



On the first day of the Conference, the Chamber, organised а panel discussion entitled "Sustainable Shipping towards 2050: a Mission (Im)Possible?". The discussion addressed the challenges facing shipowners in transitioning to a fully decarbonised Shipping Industry by 2050 and whether these specific goals are achievable, requiring the introduction of additional mid-term and short-term targets to make the energy transition in the industry feasible aiming to ensure a sustainable and efficient maritime industry that will continue to provide essential services to the planet and future generations.

The discussion was moderated by Mr. Themis Papadopoulos, the President of the Cyprus Shipping Chamber, featuring as high level speakers, Mr. Emanuele Grimaldi, Chairman of the International Chamber of Shipping (ICS), Mr. Philippos Philis, President of the European Community Shipowners' Associations (ECSA), Dr. Gaby Bornheim, President of the German Shipowners' Association (Verband Deutscher Reeder - VDR), and Mr. Nikolaus H. Schües, President of the Baltic and International Maritime Council (BIMCO).

During the Conference, there was also a 'Maritime Services Exhibition,' with more than 30 exhibitors, inaugurated by the President of the Republic, Mr. Nikos Christodoulides.

#### **EUROPEAN SHIPPING SUMMIT 2023**





The Chamber participated at the European Shipping Summit, organised by the European Community Shipowners' Associations (ECSA) and other European shipping stakeholders on 19 and 20 September 2023, in Brussels. The Summit which is considered as one of the most important maritime events in Europe, gathered together shipowners, shipping professionals and policy makers of the European and International Shipping to discuss current shipping matters and stress the importance for both the Industry and the policy makers to navigate on the same course.

Cyprus was well highlighted through the active involvement of Mr. Philippos Philis, the President of ECSA, who opened the flagship Conference with a speech, stressing the message that "Shipping is a cornerstone of European food, energy and supply-chain security and that Europe needs a strong maritime sector to maintain its global leadership". During the working deliberations of the Conference, speeches were given by distinguished guests including the Former President of the European Commission,

Mr. José Manuel Barroso and the Director-General of DG MOVE, European Commission, Mrs. Magda Kopczynska, showing the importance attached to the Conference, as well as to European Shipping.

In addition, the Cyprus Shipping Chamber, coorganised within the framework of the European Shipping Summit with other shipowner's associations a side session, entitled "How to increase the share of maritime transport in Europe's trade". The discussion involved sharing best practice cases to shift to more maritime transport.

The official opening ceremony of the working deliberations of the flagship Conference, on Wednesday 20 September, made by Mr. Philis, was preceded by a Gala Dinner earlier on Tuesday, 19 September, at the Royal Museums of Fine Arts of Belgium, during which the European Commission Vice-President, Mr. Margaritis Schinas gave a keynote speech.

#### ECSA SECRETARY GENERAL VISITS CYPRUS





The Chamber welcomed the Secretary General of the European Community Shipowners' Associations (ECSA), Mr. Sotiris Raptis, at its Monthly Members' Meeting, enhancing further the close relations the Chamber has as a Member of ECSA.

During the Monthly Members' Meeting, which was held within the framework of the "World Maritime Day" celebrations, on 28 September, the Chamber's members had the opportunity to hear from Mr. Raptis about the effects of recent European Union policies in Shipping.

According to Mr. Raptis, with less than a year left until the next European Parliament elections, the EU has recently finalised the most critical legislative proposals of the 'Fit for 55' climate package. With only a few months left for the Commission to introduce the implementing acts and the EU Member States to transpose the new regulations into national law, he focused on the most critical provisions of the new laws including the EU Emissions Trading System (ETS), FuelEU

Maritime, Alternative Fuel Infrastructure Directive (AFIR) and Renewable Energy Directive (RED). In particular, the possible effect on the uptake of cleaner fuels and a future alignment with the International Maritime Organisation (IMO) measures were highlighted.

In the framework of his visit, Mr. Raptis also had the opportunity to meet with the Chamber's Board of Directors and with the Permanent Secretary of the Shipping Deputy Ministry, Mr. Stelios Himonas. During the two courtesy meetings, there was a briefing of ECSA's plans regarding the current issues that concern European Shipping and its further strengthening. Both the Chamber and Shipping Ministry, expressed Industry's and Cyprus Government efforts to enhance EU Shipping, as Cyprus holds an important position with the third largest merchant fleet and largest shipmanagement center in the EU. The President of ECSA, Mr. Philippos Philis, who has been at the helm of the Association since January 2021, was also present at these meetings.

#### **CSC MONTHLY MEMBERS MEETING, 26 OCTOBER**





The Chamber held its Monthly Members' Meeting, on 26 October 2023, at the Four Seasons Hotel, in Limassol during which a presentation was held concerning the ESG landscape in the maritime industry to create impact.

Ms. Irene Loucaides, Managing Director of I.L Grow Sustainability Consulting Ltd., talked about the Corporate Sustainability Reporting Directive (CSRD) which requires approximately 55,000 corporations operating in the EU to report on their Sustainability performance.

The main requirements of this new directive as well as how organizations operating in the Maritime Industry can best prepare for it not just to achieve compliance but also to create positive environmental and social impact, were also presented.



#### REPRESENTING CYPRUS SHIPPING ABROAD



The Chamber's Director General participated in a number of joint Shipping related meetings in Denmark organised by the European Community Shipowners' Associations (ECSA), actively representing the Cyprus Shipping Industry.

Meetings organised included Taxation Working Group, State Aid Committee, discussing the latest developments on state aid and tonnage tax regimes.

## CSC BOARD OF DIRECTORS MEET WITH STELIOS HIMONAS, SDM PERMANENT SECRETARY



The Chamber's Board of Directors had an official meeting with the Shipping Deputy Ministry's Permanent Secretary, Dr. Stelios Himonas on 4 October.

During the meeting, the Chamber's Board, briefed the Minister on the long-standing issue of social security for EU seafarers on Cyprus flag ships and a detailed discussion was held on the various options being proposed by the Chamber towards resolving this issue and the best way forward.

Among others matters, the Board of Directors emphasised the need for the further upgrade of the services offered to the Shipping Industry with the immediate creation of a specialised "One-Stop-Shipping-Centre" at the Shipping Deputy Ministry, the complete digitalisation of the Shipping Ministry and the implementation of the Bill for the formation of a Cyprus Shipping Company with Limited Liability, so that the Cyprus Maritime Administration can become even more competitive.

#### COMMUNICATION AND IMAGE ADVISORY COMMITTEE, 2, 25/10

The Committee met to discuss and make recommendations in relation to the Chamber's Image and Communication Strategy to further support its "core business", which is technocratic/political

lobbying to the decision-makers and further enhance awareness in general, about the business and social responsibility activities of the Chamber from its internal and external communication procedures.

#### **MARINE COMMITTEE, 5/10**

The Committee noted the latest developments on the below topics: GHG Short-Term Measures, GHG Mid and Long Term Measures, LCA guidelines, Low GHG Fuel Standard (GFS), EU Fit for 55 Package Status (EU ETS, FuelEU Maritime), Bunker Fuel Quality, Ship Recycling and Ballast Water Management.

The Committee discussed the compliance process of the CII and EEXI and the issue of Overridable Power Limitation (OPL).

#### TAXATION, FINANCE AND LEGAL COMMITTEE, 25/10

The Committee met in order to mainly discuss the relevant draft Bill which has been prepared by the Ministry of Finance for the purposes of harmonisation with the EU OECD Pillar II Directive. Discussions focused on the inconsistencies between the OECD rules and the EU Directive as regards the definition of "international income", shipping under which. income from. inter alia. shipmanagement activities, was not included in the definition thus being not eligible for the exclusion/carve-out.

The Chamber Secretariat explained how this negative development can be resolved based on the practical transposition and implementation/interpretation of the relevant EU Directive on a national level. The Committee also considered the Chamber's approach towards the Cyprus Government implementation of the BEFIT proposal and the EU Foreign Direct Investment Regulation.

#### **EVENTS COMMITTEE, 26/10**

The Committee reviewed the outcome of the CSC events (Annual Dinner Dance, Beach Volley Tournament, "Maritime Cyprus 2023" Reception and Conference).

Other matters discussed by the Committee was the Chamber's "35th Year Anniversary" Gala Dinner as well as Chambers Christmas social event.


