

# CYPRUS SHIPPING CHAMBER HOLDS WORKSHOP ON EU EMISSIONS TRADING SYSTEM

The Cyprus Shipping Chamber on Tuesday March 2024, organized Workshop addressed to its Member companies regarding regulatory framework governing the EU Emissions Trading System (ETS), which entered into force on January 2024, and examined the obligations it imposes on the Shipping companies.



The Workshop commenced with a presentation from the EU ETS Administering Authority in Cyprus, which is the Department of Environment at the Ministry of Agriculture, Rural Development and Environment, on the regulatory compliance and a Q&A session. This was followed by group meetings between participants and service providers, Members of the Chamber, who presented relevant solutions to the challenges arising out of the implementation of the EU ETS.



The workshop was informative and well-attended, bringing together representatives from seven service providers and more than one hundred individuals from the Chamber's Member companies.

# CSC CHARITY/RELAY MARATHON IN SEPTEMBER TO COMMEMORATE 35 YEARS ANNIVERSARY



As 2024 marks 35 years since the Chamber's establishment, it has been decided to commemorate the special occasion by organising a "CSC Charity Marathon" on Sunday, 29 September 2024, a day after the IMO "World Maritime Day".

Participation in the event will be exclusive to the employees of the Chamber's Member-Companies and their immediate family members. The Marathon will be comprised by two separate Runs, one spanning 35km and one spanning 3.5km

The event will be charitable in its nature, and given that running is all about mobility, it has been decided that the event will aim at raising awareness and money for adolescents with mobility impairments.

In this respect, invitations were extended with our Circular No.21/2024 dated 19 March 2024 to interested Member-companies whose runners will be willing to wheel a number of adolescents with mobility impairments for the duration of the 35km Run, in the format of a "Relay Run" amongst themselves in an effort to offer them the joy of participation.

Similarly, Member-Companies have been invited to express their readiness to come forward with donations to be offered to a Cyprus charity organisation supporting adolescents with mobility impairments. Moreover, it should be noted that the success of this particular event will heavily depend on the tangible support of Volunteers from our Member-Companies in terms of providing assistance in organisation and execution.

# CYPRUS SHIPPING DISCUSSED IN BRUSSELS THE ATTACKS AGAINST COMMERCIAL SHIPS IN THE RED SEA



The European Community' Shipowners Associations (ECSA) which includes the national shipowners associations of the European Union held its regular Board of Directors meeting on 7 May 2024, in Brussels.

Attending the meeting on behalf of the Cyprus Shipping Industry were Messrs. Philippos Philis, Nicolas Hadjioannou and Thomas Kazakos.

Items in the meeting's discussions included the implementation of measures to further reduce greenhouse gas emissions and priority access to low- and zero-emissions fuels for Shipping, maritime safety, taxation ship finance, seafarer's wages, economic security, and the attacks against commercial ships in the red Sea.

In view of the recent tragic loss of seafarers lives aboard the commercial ship "True Confidence" in the Red Sea as a result of a missile strike, the urgent and imperative need for States to provide adequate protection to Shipping and to defenceless seafarers was re-emphasized.

#### **CSC - IN LONDON FOR ICS BOD MEETING**



The International Chamber of Shipping held a Board of Directors meeting on 6 February 2024 at its London Offices. In attendance was the President of the Cyprus Shipping Chamber, Mr. Themis Papadopoulos, also under his capacity as ICS' Vice-President, and CSC' Director General, Mr. Thomas A. Kazakos, representing the Cyprus Shipping Industry.

The meeting focused on current shipping policy issues and challenges such as IMO's negotiations on Green House Gas reduction measures and the Red Sea attacks. The Manila Seafarer 2050 summit and the potential of organizing a Maritime Shipping Policy Forum was also discussed.

In addition, joining the meeting was the International Transport Workrer's Federation (ITF) General Secretary, Mr. Stephen Cotton, who discussed the industry's priorities and how ICS and ITF can further co-operate.

#### ICS MARITIME LAW COMMITTEE 05/02

Discussions revolved around Minimum Wage Laws and UNCLOS issues manifesto and concern was expressed over arising out of the use of EGCS.

Liberia reported that the UK had responded State Aid Guidelines. They further stated that to their Letter of Protest but with no there was a need to pressure the EU via the substance. The Committee considered next Maritime Directors to block the ETF's steps, and was agreed by all that the ICS intentions. of the National Seafarers Wages Laws with similar discussions taking place as in the Maritime Law Committee. ICS provided an update on their ESG Initiative for which the Shipping Chamber already has expressed support for, provided that the voluntary nature of the ESG disclosure will be ensured and that iw will neither endorse nor oppose any specific reporting frameworks or ESG standards.

On the OECD Digital Tax Initiative and particularly regarding Pillar II, Hong Kong reported various issues it faced in relation to the practical application of the "commercial and strategic management" requirement.

The Committee assessed the current status Regarding the Poseidon Principles and the Sea Cargo Charter, it was reported that the Sea Cargo Secretariat had embarked on a campaign to register more owners under the initiative. This was seen as an effort to cover the bad results of the Bank's signatories to the Poseidon Principles and to camouflage any indications of greenwashing that placed their portfolio's at risk.

#### SEAFARERS REGISTRY, TRANSPORT PARLIAMENTARY COMMITEE 08/02

The Chamber's Marine Officer attended the Transport Parliamentary Committee meeting on 8 February 2024 during which the amending of the bill for the "Merchant Shipping (Registration of Seafarer's and Seafarers Register) Law of 2023 was tabled for discussion. The Chamber, in coordination with the SDM, recommended for the allowance of 72 hours -instead of 24- for the company to provide the required seafarers documentation for their registration within the registry.

This proposal along with a few other minor proposed amendments were approved. The intention is for the amending bill to be submitted to the Plenary for approval within the coming weeks.

#### COMMERCIAL OPERATIONS AND TRADE FACILITATION COMMITTEE 14/02

The committee met in order to exchange first views and share experiences in view of the enforcement of the EU Emissions Trading System (ETS) on 1 January 2024. The Chamber's Secretariat was mostly interested to know of any general queries or practical issues facing shipping companies, especially following the publication of the EU ETS implementation act bv the European Commission issued on 31 January 2024, including list allocating shipping a companies to Administering Authorities.

Queries focused on the regulatory aspect rather than the on commercial, with the latter being a matter to be addressed during the practical implementation stage of the EU ETS, and on issues relating to assumption of responsibility, timelines, bareboat charter, mandating and approach to other Administering Authorities. The Chamber's Secretariat undertook to obtain clarifications from the European Commission/EMSA via ECSA.

#### **CREWING AND TRAINING COMMITTEE 19/03**

The Committee reviewed the agenda notes of the ICS Crewing and Training Sub-Committee meting to be held on 27 March 2024 and the ICS STCW Working Group meeting to be held on 26 March 2024. The Committee noted the outcome of the IMO Sub-Committee on Human Element, Training and Watchkeeping (HTW 10) which was held between 5-9 February 2024 with the report of the Working Group on the comprehensive review of the STCW Convention and Code being the most important topic of discussion.

The committee also reminded of the Mission to Seafarers (MTS) Suicide Awareness course called SafeTALK and agreed to consider the possibility of cooperating with the MTS on the organisation of a course in Cyprus within 2024 for the Chamber's Members. The Secretariat undertook to investigate interest from Members and arrange the course if sufficient placements are secured.

# CSC WELCOMES EU COMMISSIONS ASSURANCE TO GIVE SHIPPING PRIORITY ACCESS TO OW- AND ZERO- EMISSION FUELS

On February 2024, the European Commission in the context of presenting its assessment for EU's 2040 climate target committed to address barriers to the deployment of alternative low- and zero-emissions fuels (including e-fuels and advanced biofuels) and extend to the maritime sector priority access to them, over sectors that have access to other decarbonisation solutions

In its assessment, the Commission recommended reducing the EU's net greenhouse gas emissions by 90% by 2040, relative to 1990. The 2040 climate target will reaffirm EU's determination to tackle climate change.

The Chamber, welcoming the Commission's assurance expressed its belief that prioritising the maritime sector's access to these fuels not only accelerates the pace of decarbonisation in Shipping but also ensures the industry's competitiveness and sustainability in the long-term.

By fostering an environment conducive to innovation and investment in green technologies, the Commission paves the way for a greener, more resilient maritime sector and a sustainable future for Europe in general.

Chamber Additionally, with the satisfaction, noted the Commissions supportive consideration to the IMO Strategy on the reduction of GHG shaping emissions in differentiated targets for Shipping, as well as the need for significant investments required in the existing fossil fuels based energy production models with renewable and low-carbon fuels necessitated by the shipping sector.

# CHAMBER UNITES VOICE CALLING FOR THE RELEASE OF GALAXY LEADER'S CREW

19 February 2024, marked three months since the Houthis seized vehicles carrier Galaxy Leader and its 25member crew in the Red Sea. The Cyprus Shipping Chamber, in concert with 26 other members of the Maritime Industry from around the world, cosigning a joint statement, united their voice to express concern for the captive seafarer's lives and called on the Houthis for their immediate release. The statement stressed that the 25 captive seafarers are innocent victims of the aggression against ongoing shipping and their plight is a major concern as the merchant shipping community continues to come under attack. The statement further stressed that international organisations and States must make all efforts to secure their release.



# CHAMBER STRONGLY WELCOMES EU'S OPERATION ASPIDES



On the same day the EU launched its defensive maritime security operation in the Red Sea, dubbed operation "ASPIDES". The operation retains a defensive mandate aimed at restoring and preserving freedom of navigation in the Red Sea and the Gulf. In that context, it will ensure maritime situational awareness accompany merchant vessels and protect them from cross-sectoral attacks at sea. The Chamber strongly welcomed the launch the operation stressing that European the presence in area addressing security concerns keeping seafarers safe is essential while at the same time supports all coordinated efforts -including diplomatic action aimed at deescalating the crisis.

# THE CYPRUS SHIPPING CHAMBER CONDEMNS DEADLY ATTACK AGAINST COMMERCIAL SHIP "TRUE CONFIDENCE"

The Cyprus Shipping Chamber strongly condemned the missile attack against commercial ship, "True Confidence", that claimed the lives of three of its crew members, while injuring at least four others on Wednesday, 6 March 2024, in the Red Sea.

The Chamber extended its sincere condolences to the families of the seafarers who died, as well as wishes that those who went missing are found and hopes for the speedy recovery of those injured, some in a critical condition.

The loss of innocent and defenceless seafarer's lives in the context of the ongoing attacks against commercial ships in the Red Sea, is a highly unacceptable and dangerous development making it imperative, that States and the international lawful community, urgently take all necessary measures in securing commercial ships and their personnel navigating the specific area.


